I examined the above described horse at Jazcom Equine spelling farm, The Oaks, NSW on the 28th March 2017.

My examination was purely clinical in nature employing no ancillary aids (ie radiography, laryngoscopy, electrocardiography, ultrasonography).

My examination revealed a colt:

- With a normal temperature
- Without nasal discharge
- Free from recent injury
- Free from skin disease
- Not lame at walk nor trot
- With two palpable testes
- Without any detectable abnormality on auscultation of the cardiothoracic region.

Thus my examination failed to reveal any abnormality which would prevent the horse entering training to race.
